




Research Question: How does onboarding affect a community?

• How does the onboarding affect the governance of a community?

Theoretical Lens: Institutional Theory

- Institution
 - are taken for granted
 - structures, roles, and rules (= Governance)
 - constrain and shape human interaction (Barley and Tolbert 1997)
- Institutionalization
 - establishment and change of institutions
 - (Mignerat and Rivard 2009; Powell and DiMaggio 1994; Miller and Friesen 1980)



Institutionalization of Governance

Governance: structures, roles, and rules

- New project no governance
- Growing project refinement of governance
 - (Bacon 2012; Kelty 2008; O'Mahony and Ferraro 2007)
- Pivoting project pivoting of governance
 - (DiTullio and Staples 2013)

Proposed Method

- Participant observation (van Maanen 1988)
- Meaningful engagement with online communities (Kozinets 2015)
- Generate data through engagement (Dourish 2014)
- Points in time between which changes in governance are observable (Miller and Friesen 1980)
- Context: An academic OSS project that joins a foundation

Contributions

RESEARCH

- Changes in governance as process of institutionalization
- Governance change in open source community as strategic action to reach a goal

PRACTICE

- Understanding the process allows for creating a smoother transition
- Foundations and communities can prepare ahead of time for the needed changes in governance
